- *The Redbean House v. Colonnade Wilshire Corp.* obtained a verdict in favor of The Redbean House, along with full recovery of attorneys' fees and costs, in a five-year real estate dispute.
- *Disney v. deadmau5* represented deadmau5 in trademark proceedings over deadmau5's intellectual property rights.
- *Honest Tea, Inc. v. The Honest Company, Inc.* defended Honest Co. in trademark proceedings.
